**RE: Compliance with Buy American Act, Surface Transportation Assistance Act & American Reinvestment and Recovery Act provisions**

To Whom It May Concern:

Steelscape's various metallic-coated and pre-painted products are manufactured in the United States. Consequently, construction materials manufactured using Steelscape's products will comply with the Buy American provisions of the Buy American Act ("BAA").

Although construction materials manufactured using Steelscape's standard products comply with BAA, they will not comply with the Surface Transportation Assistance Act ("STAA") of 1982, the American Reinvestment and Recovery Act ("ARRA") as amended, and may not comply with some state statutes.

Steelscape may be able to provide products that do meet both the STAA and ARRA requirements if utilizing hot roll bands melted and poured within the United States. Please inquire for availability.
