A minimum of 25% restocking fee will apply for all cancelled or returned stocked items.

To the extent permitted by applicable law, Customer hereby waives presentment, demand, protest, and notice of nonpayment and shall reimburse STEELER CONSTRUCTION SUPPLY, LTD. for all costs which STEELER CONSTRUCTION SUPPLY, LTD. incurs in connection with the collection of this account, including all attorney fees, whether or not litigation is commenced. This agreement shall be governed by and construed in accordance with the laws of the Province and venue for resolution of any dispute arising hereunder shall be in the Province & Municipality of creditor's choice and shall not be removed therefrom.
